While we normally age our wines 2-3 years and offer them through the cellar door, we will reserve back vintages for members to enjoy as vertical reserve releases.

- Private tastings at your request
- 10% off all cellar purchases
- Invitations to play on the par 3 practice course, Boules or use the golf putting green during your visit

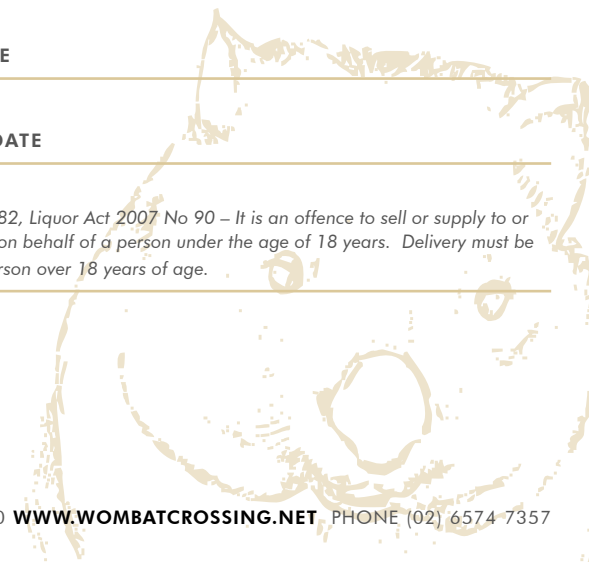

PRIVACY STATEMENT

Wombat Crossing Vineyard respects the privacy of its members and customers and has in place a Privacy Policy to ensure compliance with all relevant government privacy laws including the Privacy Act 1988 (Cth) as amended and the National Privacy Principles under the Privacy Act 1988 (Cth).

WHAT PERSONAL INFORMATION IS COLLECTED?

In order to supply goods or services to customers and members of the Wombat Crossing Vineyard Field and Wine Club, Wombat Crossing Vineyard collects the following personal information about individuals:

- Name
- Contact numbers – landline; mobile; and email address
- Mailing address
- Delivery address, including any delivery instructions
- Date of birth
- Date member joined
- Credit card number, expiry date and name on the card
- Sales history
- Communication between the individual and Wombat Crossing Vineyard

Wombat Crossing Vineyard only collects personal information about customers

and members that is necessary to provide customers and members with goods and services and to carry out its business functions and activities. If you choose not to provide Wombat Crossing Vineyard with personal information, Wombat Crossing Vineyard may not be able to provide you with goods or services.

USE OF PERSONAL INFORMATION

Wombat Crossing Vineyard does not sell or rent out any of the personal information it holds and protects the security of that information.

Wombat Crossing Vineyard uses personal information about customers and members to provide goods and services and to carry out its business functions or activities. Wombat Crossing Vineyard may also use the personal information to notify you about special offers, coming events, Wombat Crossing Vineyard Field and Wine Club lunches and other benefits being offered to members.

Wombat Crossing Vineyard may disclose personal information to third parties who perform services for Wombat Crossing Vineyard, including credit checking, mailing, marketing, packing and delivering goods. Such persons are bound by confidentiality arrangements or obligations with Wombat Crossing Vineyard which address the privacy of personal information.

Wombat Crossing Vineyard may be required or allowed by law to disclose personal information to the police, government, industrial or regulatory bodies or third parties.

ACCESS TO PERSONAL INFORMATION

An individual can seek access to his/her personal information collected by Wombat Crossing Vineyard by writing to Wombat Crossing Vineyard.

CORRECTING PERSONAL INFORMATION

If you believe that the personal information about you held by Wombat Crossing Vineyard is not accurate, complete and up-to-date, you can write to Wombat Crossing Vineyard and ask that it be corrected.
